Review of 2009 Activities



Action was fast and furious in the double elimination dodgeball tournament, with a total of 16 teams competing.

The L-P School Foundation (LPSF) was involved in four major activities and events during 2009 – developing a website, coordinating the annual Senior Project, reaching out to alumni, and making a grant to the L-P Schools.

The first major activity of 2009 was development of the L-P School Foundation's website (www.lpschoolfoundation.org), using PV Communications and a number of LHS graduates. The website will allow us to better communicate our activities, and

how the Foundation is assisting the L-P Schools. Additionally, the website will allow you to connect with classmates, other alumni, and school supporters. Registration at our website takes just a few minutes, and there is never a charge.

The second major activity undertaken by the L-P School Foundation was the Class of 2009 Senior Project. Initially held in the year 2000, Senior Projects have now been a traditional

activity for ten consecutive years. The Class of 2009 project had two main components – a dodgeball tournament and a carnival for the younger children.

A total of 16 teams entered the dodge-ball tournament, and perennial power-house Beano's Buckeye Ballroom again came away as the champion. As they have in past years, the Beano's team donated their prize winnings back to the L-P School Foundation. Thank you, Beano's, for your support!

The carnival drew a large number of McMullen and Budd School students, and the highlight was five inflatable "bouncer" structures, which the youngsters (and some "oldsters") thoroughly enjoyed. Some other games and activities included face painting, bean bag toss, knock over the milk bottles, and the Mexican hat game. Goodie bags were also given to the younger students.

The concession stand featured homemade bratwurst and pulled pork sandwiches. The hog was donated by Jack and Crystal Ashby, parents of Class of 2009 President Megan Ashby. Thank you, Ashby family! With sunny skies and temperatures in the 80's, lots of pop, water and Gatorade were sold, too.

Some of the participants and spectators brought food items for the Helping Hand food pantry, which was greatly appreciated. The Class of 2009 raised over \$2,100 with the day's activities. Subsequent donations lifted the overall total for the Class of 2009 to a little over \$5,000.

Another major activity undertaken by LPSF in 2009 was a campaign to contact L-P alumni and other school supporters. Over 2,200 letters were sent to alumni and supporters in 45 states. Donations were received from 166 supporters in 21 states, including 72 donations from first-time supporters of the L-P School Foundation. More than \$12,000 was raised through these efforts, and LPSF sends its thanks to all of those who supported this campaign.

The final major event of 2009 was LPSF's grant of \$1,500 to the L-P Schools. Coupled with a grant of \$3,047 from the L-P School District Endowment Fund held at the Ashland County Community Foundation, these funds allowed the school to purchase a whiteboard for the McMullen building. The Foundation's intent is to provide one grant each year to the L-P Schools, and that grant will be approximately 5% of our fund balance. That will allow LPSF to grow our fund balance, and thus provide increasing support to our schools each year in the future.

The 2008 survey said . . .

In last year's newsletter we included a short survey. We want to thank everyone who responded, and share the results with you.

We asked about particular programs or areas of interest that we should emphasize as we make grants.

While not an all-inclusive list, the responses suggested that LPSF grants should be used in the areas of math, reading, computer technology, music and the arts, foreign language, and public speaking or presentation skills. One respondent summarized the majority view by simply suggesting academics in general. Academics always have been, and will continue to be our primary focus. We work with the school administration to spread our grant money

across all four buildings in a variety of academic fields.

The survey included several questions about holding some type of donor recognition event.

About one-half of the respondents were against this type of event, and some suggested that any funds raised by LPSF should be expended to benefit the students. A number of people suggested that attendees could pay for their meal, and 70% of the respondents said they might attend an event if it was held. Given the responses, we are not planning to hold a donor recognition event at this time, but we may revisit the issue in the future.

Finally, we asked for any other thoughts, suggestions, or criticisms.

Several people thanked us for the newsletter and the overall efforts of LPSF. We appreciate those comments, and will continue doing our best to help the L-P Schools.

One comment specifically remarked about a lack of Perrysville representation on the Board. We did ask, and several people from the Perrysville area declined to serve on the Board, citing other commitments. LPSF is a volunteer group, and we will never decline any offer of help. We welcome anyone and everyone to attend our meetings, or to assist LPSF in any manner. Just contact one of the trustees listed on Page 3 of this newsletter for more information.
