\$100,000 Challenge Match for 2022!

The Foundation has a wonderful growth opportunity, thanks to an extraordinary challenge match.

This \$100,000 Challenge Match is being offered by the Ramser Family for the L-P School Foundation's 2022 Annual Campaign.

The match is designed to encourage first-time gifts from new supporters, or increased gifts from previous supporters. Here are the details:

• The match will be done on a dollar-for-dollar basis, up to a maximum amount of \$100,000.

- Any gift from a first-time donor is eligible for the match.
- For previous donors, the <u>difference</u> between their 2022 donation and their 2021 donation will be eligible for the match. (For example, a 2022 gift of \$125 that follows a 2021 gift of \$100 would result in \$25 being match eligible.)
- Donations must be received between January 1, 2022 and December 31, 2022 to be eligible for the match.

IRA Gifts from Larry and Karyle Mumper

Larry and Karyle Mumper made an amazing impact on education in the L-P Schools with their two gifts earlier this year.

Their first gift will allow the Loudonville-Perrysville School Foundation to significantly increase its annual grants to the Loudonville-Perrysville Schools, not just for this year, but for every year going forward.

Their second gift established the Larry and Karyle Mumper Scholarship Fund at the Ashland County Community Foundation. This scholarship will be awarded every year to a student from the Loudonville-Perrysville Schools who continues their college studies in the STEM field (Science, Technology, Engineering, and Math).

Mary Lou (Petty) Budd, LHS 1947, is still giving back to help her high school alma mater. Mrs. Budd now lives in the Chicago area, and she has donated to the L-P School Foundation in 12 separate years.

Mrs. Budd has long been involved with and interested in supporting education. In the early 1960's she was a substitute kindergarten teacher in Delaware. In the late 1960's, while living in Illinois, she worked on installing a crosswalk to improve the safety of children walking to and from school. In the late 1970's she returned to school to earn a certificate in Library Science and then was a grade school librarian for many years in Milford, Ohio. She supports the L-P Schools, rather than the schools where she taught, simply because she is "a Loudonville girl at heart."

The local ties are deep and significant. Mary Lou was married to Curtis Eugene Budd, the grandson of C. E. Budd, for whom the Budd Building was named. Both her husband, and then later their daughter, attended classes in the Budd Building. Redbird Alumni Challenge

The 6th annual Redbird Alumni Challenge was held over graduation weekend, and ended at midnight on May 30. With 37 class members making donations, the Class of 2006 solidified its claim as "perennial powerhouse" with its fifth victory in the six years of this contest. In its final year of eligibility the Class of 2001 finished in second place with 28 donations.

This annual event is open to the 20 most recent classes to graduate, and the winning class is based on the NUMBER of donors, NOT the dollars donated. During the 2021 challenge, a total of 145 graduates from these last 20 classes made donations, and the total collected to help our schools was \$2,818.

Since the year 2016, a total of 610 young alumni have donated \$12,160 to benefit the L-P schools.


2021 Teacher Mini-Grants

In July the Foundation awarded nine Teacher Mini-Grants in the total amount of \$3,882. This is the 5th straight year LPSF has awarded grants directly to teachers, based upon a competitive application process.

Teacher Mini-Grants are to be used for materials, equipment, or other expenses related to a program or project not supported by the school budget, and are limited to \$500 per teacher each year.

Donations and Grants In 2021

As of press time, the L-P School Foundation has received 2021 donations of \$80,233 from 557 supporters located in 28 states. Since its incorporation in 2008, the Foundation has received support from an incredible 1,416 donors!

As a result of these donations, along with the <u>Senior Projects</u> organized since the year 2000, the L-P Schools have received cumulative grants of **\$150,500**!

This year the L-P Schools received total grants of \$21,367. These grants helped purchase laptops for the McMullen Building and STEM/Robotics materials in the high school, assisted with the track renovation at Redbird Stadium, funded the nine Teacher Mini-Grants described further on this page, and provided designated funding at the McMullen School.
